## **SATURDAY**

### **OPENING**

### **OFFICER REPORTS**

- Treasurer Report: Bruce B. (report available upon request)
- We are right where we should be at this time of year.
- Balance is a little high because of Convention funds, and because registration fees for Assembly have been collected, but our bill has not been paid to the hotel.
- Contributions are coming in nicely from groups and districts. We are where we should be this time of the year.
- The 2019 Spring Assembly cost the Area about \$8,000. The 2019 Fall Assembly should be less approximately \$6,500 \$7,000 because it is smaller.
- Budget Discussion: Discussion was held about the cost of the Assembly to the Area over the last two years. Some confusion about terminology was expressed and a better wording will be used going forward. Bottom line, the Assembly always costs the Area money. Our registration fees do not cover the cost of the Assembly.

- Delegate Report Terry W. (report available upon request)
- Terry explained Panel numbers and how they work, what occurs at the World Service Conference, what her responsibilities are as our Delegate, and how she works with Al-Anon Trustees.
- Our new theme for next year is *Dreaming Big with a 20/20 Vision*. 2019 was our first trilingual WSC.
- The Southeast Region, of which Virginia is a member, has a Regional Trustee vacancy for the second year in a row now.

- There are three conventions coming up 2020 AA International Convention in Detroit, 2021 Virginia Area Convention, and 2023 Al-Anon/Alateen International Convention in Albuquerque, NM
- Policy Committee Discussion
  - A conversation is starting about prior AA members and their participation in Al-Anon service.
  - There are currently text revisions going on for our 2022 Service Manual, in order to edit/remove text that is procedural in nature, not policy related.
  - "Open" and "closed" terminology for our meetings is being changed to "Families, Friends, and Observers Welcome" and "Families and Friends Only", respectively.

### **COORDINATOR REPORTS** (most available upon request)

- Public Outreach Val P. NVSC has decided not to purchase translation equipment; it is much more economical to rent it. We sold about 100 bilingual calendars at Convention. PSA's can be downloaded from WSO website. We have a new fact sheet for professionals for those districts participating in Adopt-A-Doc outreach service. Al-Anon Faces Alcoholism is now going to be kept continually in circulation, not just available once per year.
- Literature/Forum Tom S. for Ann F. Sharings are needed. Please encourage all groups to subscribe to The Forum. Currently only 50 groups subscribe. The cost is only \$11/year.
- Group Records Leslie K. Copy of group records process was included in everyone's packet. It's a simple three step process. Contact DR, DR submits changes, Group Records Coordinator updates the database, which also updates WSO's database.
- AAPP Debi H. Alataeen is Al-Anon's largest vulnerability. We deactivated 60 AMIAS's. We have 12 districts with Alateen meetings, but 19 districts with at least one AMIAS sponsor. Debi encourages all DR's to stay on top of the sponsors in their district. MEAC and ESAC were both held this year.
- Alateen Ginny K. Bull Run will hold the next Alateen workshop in November. Hoping to be in Roanoke in January.
- 2019 Convention Christy B. The speakers were phenomenal. 88 silent auction baskets were donated; the event made \$4,000. Workshop handouts are on the area website.
- 2021 Convention Val P. There will be a meeting tomorrow immediately after Assembly to recruit committee chairs. Filled hotel liaison, registration on the spot. Need merchandise chair. Brooke volunteered to help procure speakers. Need workshop help (maybe 2-3 people), silent auction help, boutique help, Spanish participation help, etc. Wendy W. has agreed to be Convention treasurer again.
