APPROVAL OF TREASURER'S REPORT FOR THE FIRST QUARTER OF 2023 (Laura L.) Report posted on Area website. Prepared April 25, 2023:

The Drupal invoice came in 2023 rather than 2022, so the website expenses appear high but has been budgeted. Taxes filed on time. Convention account at \$15000. The new use of QuickBooks adds a class to every transaction, allowing us to look at individual line items. Regarding the question to invest reserve funds in Treasury Bonds, the Officers decided not to do this. The return rates on Treasury bonds are not much more than our bank account provides and simplicity of accounts makes transitioning easier.

Peter M. – doesn't agree with decision on T-bills and asked if consideration could be given to moving the reserve fund to an institution that pays more current interest rates or getting a CD that pays more than what we're getting. Willing to discuss with Laura. Laura L. – considered changing banks but staying with Bank of America which is more convenient in location. Benefits don't outweigh changing. Open to hearing suggestions.

- Our district meetings are hybrid and the day before we ask who will be able to make it in person meeting and who will be virtual.
- Our virtual meeting is later in the evening so we do get a lot of drop-ins from out of the area. We do have a lot of regular members that are from other areas. We do miss the in- person aspect, so we started a spinoff fellowship group that meets for lunch occasionally.
- Our group used to be a hybrid group and over time we got separated, so we took a group conscience and decided they wanted to split. The virtual group doesn't have a treasurer and the in-person groups doesn't have a GR, so my

solution is whenever I get announcements or anything I send out all the information to both groups. I was wondering if we could have sister groups and have their treasurer cover both groups even though we don't interface.

- We had a pizza party with both in-person and virtual members. I think that it would be good for virtual groups to meet once a month for coffee for those able to come in-person.
- In a virtual meeting it's easier to stalk people. We have a situation where a member's spouse joins the meeting
 anonymously. I don't know if anyone has suggestions on how to handle that. Suggestion: we have a document on
 safety guidelines in meetings.
