Virginia Area Policy: Transforming Electronic Meetings to AFGs

Approved with revisions at the January 8, 2022 Outgoing/Incoming Officers' Meeting

Revised January 22, 2022

Introduction

The need for a Virginia Area policy regarding the transformation of Electronic groups to Al-Anon Family Groups (AFGs) grew out of the 2021 World Service Conference (WSC) approval of two motions. The first of these motions changed the status of permanent electronic groups with no representation to Al-Anon Family Group status entitled to elect representatives. The second of the motions allows for all permanent electronic groups to form a new Electronic Area and petition the WSC for admittance to that body.

After the new Electronic Area is formed and is admitted to the WSC (anticipated to occur in April, 2022), each newly formed AFG then may decide whether it wants to remain affiliated with the newly formed Electronic Area or if it wants to petition an existing geographic Area for admission to that Area. Until the new Electronic Area is admitted to the WSC, permanent electronic groups are still considered as non-voting, non AFGs. Once the new Electronic Area is admitted to the WSC, the new Al-Anon policy is that all groups are AFGs and are entitled to elect their representatives and have voice and vote at the District, Area and World Service levels.

To change a group to a new Area, the Virginia Area's policy will be guided by the 2018-2021 Al-Anon/Alateen Service Manual, version 2, page 158, "Miscellaneous: Renaming an Area, Changing a group/District to a new Area. Since, an AFG may belong to only one Area, the petitioning AFG must also petition to leave their Electronic Area at the same time as it is asking for admission to the Virginia Area. The newly formed Electronic Area will be considered as having a contiguous boundary to every other Area.

The Virginia Area Policy for transformation of electronic meetings to AFGs will account for 1). Permanent electronic groups petitioning to join the Virginia Area; 2). A Virginia Area AFG that wishes to leave the Virginia Area and petition to join a contiguous Area, such as the new Electronic Area; 3). A Virginia Area AFG that was previously face-to-face and now wishes to be permanently electronic and maintain its historic District and Area affiliation.

1. Permanent Electronic Groups Petitioning to Join the Virginia Area

In keeping with the current Al-Anon/Alateen Service Manual recommendations, the Virginia Area will accept the petitioning group, provided that the following conditions are met:

The group belongs to an Area that is a recognized member of WSC.

- The Area that the petitioning group is leaving is contiguous to the Virginia Area.
- The group has held a Group Conscience and the members agree to this process.
- The group petitions the Area it wishes to leave and is granted approval. That Area sends a letter to the Virginia Area indicating that it agrees to this process.
- The group agrees to give up participation in the first Area. A group may belong to only one Area.
- The group petitions the Virginia Area for approval to join. Once the Virginia Area grants approval, the Virginia Area will send a letter stating such to the Area that the petitioning group is leaving.
- The petitioning group agrees to abide all the recommendations for starting a new group in the current version of the Al-Anon/Alateen Service Manual, and in the WSO Guidelines G-12, "Starting an Al-Anon Group," or in the G-19, "Starting an Alateen Group."

District Affiliation of the Newly Admitted Group

If the new group has some connection to an existing Virginia Area District and that District is willing to accept the new group, the newly admitted group will be assigned to that District, and Virginia Area Group Records procedures for indicating such will be followed.

If for some reason, the new group *does not* have a connection to an existing Virginia Area District, the Virginia Area Officers may assist the new group in establishing a connection. Factors to take into consideration for this potential situation may include whether or not the District in question holds their District meetings either virtually or in a hybrid format, to allow for a Group Representative (GR) from outside of Virginia to participate in District business. The District may agree or not agree to accept the new group, based on their District's Group Conscience.

Another factor to be considered in admitting a petitioning electronic group to an existing District is the cost of sending a representative to the Virginia Area Assemblies. Traditionally in the Virginia Area, the groups pay the fees for their GR to attend Assemblies. If the group's treasury cannot pay that fee, the group may appeal to their District for financial aid. If the District also cannot afford to cover the costs, the District may appeal to the Virginia Area. The Virginia Area maintains some funds for this financial aid, but the Area treasury has limits. If a group has a GR from a distance so far from the Virginia Assembly site that transportation costs would be prohibitive, the group will need to carefully consider what an appropriate action is. Every group has the right to representation, but it also will need to be practical in selecting how to get their representative to the Assembly.

Currently the Virginia Area has a contractual obligation to hold its Assemblies at a hotel in the Richmond area. The contract is valid for two more years, until the end of the 2023 Fall Assembly. The possibility of the Virginia Area hosting hybrid Assemblies is under investigation, but no decision has yet been reached. So, the cost of sending a representative to Assemblies will continue for the immediate future. Groups and Districts will need to weigh all these factors as they exercise their autonomy in choosing who to best represent them.

Additionally, the District considering accepting a petitioning electronic group, should consider the electronic group's prior experience with Al-Anon's service structure. Since Electronic Groups were not a part of any service structure prior to the 2021 WSC, some of its members may have not participated in any District meetings or Area Assemblies. Is the District considering admitting this group willing and able to undertake service orientation and provide a Service Sponsor for a new GR? Is the District willing and able to welcome and support the new group?

2. A Virginia Area AFG Petitioning to Leave the Virginia Area and Join a Contiguous Area

In the case of a Virginia Area group that wishes to leave the Virginia Area and petition to join another Area, either the new Electronic Area or a physically contiguous Area, the process is similar to that of a group petitioning to join the Virginia Area.

- The new Area to which the Virginia Area group wishes to join is a recognized member of the WSC.
- The new Area the leaving group wishes to join is contiguous to the Virginia Area, either an Area that borders Virginia geographically, or the new Electronic Area, which is considered contiguous to every other WSC Area.
- The leaving group has held a Group Conscience and the members agree to this process.
- The group petitions the Virginia Area and is granted approval to leave the Virginia Area. The
 Virginia Area sends a letter to the Area the group wishes to join, indicating that the Virginia Area
 agrees to this process.
- The leaving group agrees to give up participation in the Virginia Area once it is accepted into the new Area. A group may belong to only one Area.
- The leaving group petitions the new Area for approval to join. The new Area sends the Virginia Area a letter indicating that the leaving group is accepted into the new Area.
- The leaving group agrees to abide by the new Area's guidelines for participation in that Area.

3. A Virginia Area AFG That Was Previously Face-to-Face and Now Wishes to Be Permanently Electronic and Maintain its Historic District and Area Affiliation

Some Virginia Area groups that changed from meeting face-to-face to temporarily electronic, either via phone or a virtual platform, during the Covid-19 shutdown, now wish to remain permanently virtual. They also wish to retain their historic affiliation with their District and with the Virginia Area. That will be possible, once the WSC does in fact accept the new Electronic Area. Previously a group that wanted to

list their group's electronic contact information with the WSO was required to register as a permanent electronic group and then ceased belonging to the Virginia Area. Acceptance of the new Electronic Area into the WSC does away with that requirement. A group may become permanently electronic and remain a member of the Virginia Area and their historic District.

The Virginia Area Group Records procedures will facilitate the listing of permanent electronic groups in the Virginia Area and the WSO Group Records.

Formerly Face-to-Face Virginia Area Groups that Wish to Become Hybrid

Prior to the 2022 WSC 's acceptance of the new Electronic Area, Al-Anon policy prevented registration of groups that met face-to-face while simultaneously providing an electronic platform, also known as a hybrid group. The WSO currently has no plans to distinguish groups as face-to-face, electronic only, or hybrid. All groups are now considered as Al-Anon Family Groups by the WSO.

The Virginia Area will establish a Group Records procedure to list hybrid groups' meeting information at both the Virginia Area and the WSO levels.

Revisions from the Jan. 8, 2022 Officers' Meeting

This policy supersedes any existing VA Area motion or motions on moving groups or districts within the VA Area or between the VA Area and any other contiguous Area.

Appeal Process

The 2018-2021 Al-Anon/Alateen Service Manual states, on page 51-52, under "Group Conscience," that "Concept Five tells us that members have the right of appeal." It then describes the process by which a decision can be appealed for reconsideration by the body that made the decision. The VA Area is guided in all its decisions by the spiritual principles in the Three Legacies, the Steps, the Traditions, and the Concepts of Service. In the matter of accepting or rejecting a petitioning electronic group into the VA Area, these principles will be adhered to by the VA Area.
